### Website Cookie Policy and Terms and Conditions

Authentic Health D.O., LLC, DBA: Davis Osteopathic Center, (the “Practice”), is a private medical practice and exercises care for your personal information. Please note that our Cookie policy and Terms and Conditions policy are separate from our Notice of Privacy Practices policy, which is a more in-depth policy we enact if you should request to become one of our patients.

## Cookie Policy

### What is a Cookie?

Cookies are small pieces of data stored on your browser from visiting a website. They typically help keep track of settings you select and actions you take on the site, and they can help us ensure that our website remains protected from fraud or attack. - **How the Website Collects Data:**
  - Our platform may collect certain data from you when you access our pages.
- **What Data is Collected:**
  - For compliance with the Health Insurance Portability and Privacy Act of 1996, we require that you call our office number via phone, to prevent digital intake of your personally identifying information (PII), personal health information (PHI) or payment information through our Wix website.
  - Our website may collect the Internet protocol (IP) address used to connect your computer to the Internet, device and connection information. We may use Wix’s software tools to measure and collect session information, including page response times, country location, length of visits to certain pages, page interaction information, and methods used to browse away from the page.
- **How Data is Used:**
  - Via the Practice
    - Any data automatically collected regarding your session information is used solely for the purpose of site traffic analysis, which we use to determine possible improvements to the website, our services, or marketing opportunities. While the website may automatically collect it, the practice does not have visibility into your specific IP address used to access our site.
  - Via Wix
    - Wix does not sell or share your personal information for monetary compensation. By accessing our site or others hosted through Wix website builder, Wix may be able to offer you more personalized advertisements or content. You can switch this off by accessing the toggle feature on the [“do not sell or share my personal information”](#) page.
- **Who Has Access to Data:**
  - We (the “Practice”) do not have visibility into your IP Address through our site traffic analytics. Employees with access to our site traffic analytics may be able to view other session information for the purpose of possible improvements to the website, our services, or marketing opportunities. The Wix website platform can access data collected through the Wix website.
- **How the Data is Protected/Stored**
  - Our company is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to sell our services to you. Your data may be stored through Wix.com’s data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.
  - [All Wix sites use HTTPS and SSL protocols, providing security for your site and its visitors. Any data sent between our site and your browser is encrypted, ensuring a safe browsing experience for all.](#)

- **How You Can Exercise Your Data Rights:**
  - As we do not collect personal information on our Wix website (a call must be placed to schedule with or contact us), we do not have specific data (name, address, etc.) to be purged on request, nor can we tie session information to a specific user, as we do not have visibility into the IP Address per session. However, if you would like to limit the information that Wix automatically collects related to your session on the website, or delete cookies, you can adjust your privacy settings on your personal browser:
